## FIRST AMENDMENT TO THE BYLAWS OF THE ASSOCIATION OF APARTMENT OWNERS OF THE BREAKERS (Formerly Known As "The West Maui Breakers")

THIS FIRST AMENDMENT TO THE BYLAWS OF THE ASSOCIATION OF APARTMENT OWNERS OF THE BREAKERS (Formerly Known As "The West Maui Breakers") ("Amendment") is made on <a href="September 1/24">September 1/24</a>, 2009, by DOUGLAS E. MYERS, Trustee of The Douglas E. Myers Revocable Trust dated June 8, 2005, with full powers to sell, lease, mortgage, exchange, or otherwise dispose of, or deal with any property of said Trust ("Developer") and 3702 LOWER HONOAPIILANI, LLC, a Colorado limited liability company ("LLC") (Developer and LLC are hereinafter collectively referred to as "Declarant").

#### **RECITALS**

- A. Declarant executed the Bylaws of the Association of Apartment Owners of The West Maui Breakers ("Bylaws") dated effective February 25, 2005 and recorded the Bylaws in the State of Hawaii Bureau of Conveyances ("Bureau") as Document Number 2005-069182.
- B. Developer and LLC are the owners of all of the Apartments in the condominium project established by the Bylaws and has not conveyed any Apartments.
- C. Declarant, as the owners of all of the apartments in the Project, have also agreed to and approved such amendments pursuant to Section J.14 of the Bylaws.

NOW THEREFORE, pursuant to Section J.14 of the Bylaws, the Bylaws is hereby amended as follows:

- 1. <u>Change of Project Name</u>. By amendment to the Declaration made concurrently herewith, the name of this Project has been changed to "The Breakers". Accordingly, the name "West Maui Breakers" is deleted in each place it appears in these Bylaws and replaced with "the Breakers".
- 2. <u>Deletion of Weight Limit on Pet Dogs</u>. Section E.3.b of the Bylaws is amended and restated in its entirety to read as follows:
  - b. <u>Certain Pets Allowed</u>. Owners and tenants are permitted to keep one dog or one cat. There shall be no more than one pet in each Apartment.

This Amendment may be executed in counterparts, and all such executed counterparts shall constitute the same agreement. Duplicated unexecuted pages of the counterparts may be discarded and the remaining pages assembled as one document.
